Program Overview

The New York State Law Enforcement Agency Accreditation Program aims to provide law enforcement executives of eligible police departments and sheriffs' offices formal recognition of their compliance with 110 professional standards that focus on administration (51), operations (47), and training (12). To obtain accreditation, an agency must develop and implement policies and procedures that comply with all 110 standards.

The program standards, developed by New York State law enforcement professionals and approved by the Law Enforcement Agency Accreditation Council, are designed to enhance the effectiveness, efficiency and professionalism of an agency, promote training and foster public confidence in law enforcement. Accreditation demonstrates that the agency performs in a consistently professional manner, has formalized policies in place to govern its operational practices and procedures, and that its employees contribute to the agency's mission and know what is expected of them.

Participation in the Law Enforcement Agency Accreditation Program, established by the state in 1989, is voluntary. Executives who want their agencies to participate must submit an application and a participation agreement to the Division of Criminal Justice Services (DCJS). Once an agency has applied, policies and procedures that are aligned with the program standards must be developed. This process typically takes between six months to two years, depending on the staff time devoted to the project and the number of policies that must be revised and/or developed to meet the program standards.

When an agency's executive is confident that the agency can adequately demonstrate compliance with every standard, an assessment is conducted. Assessments occur on-site at the agency and are performed by three assessors who spend three days reviewing the agency's written directives and accompanying documentation, conducting interviews and making observations within the agency. If the assessors determine that the agency has demonstrated compliance with all program standards, they submit a written report detailing the specifics of the assessment to the Council, along with a recommendation that the agency be awarded accreditation.

Agencies are accredited for five years and during that time they must maintain compliance with all program standards. Maintaining compliance is determined, in part, by site visits conducted by accreditation program staff from DCJS and the agency's submission of an Annual Compliance Survey, which is a progress report intended to ensure that any lapses in compliance are immediately identified and remedied. The process occurs every five years for agencies seeking to remain accredited; the Council grants reaccreditation after agencies demonstrate that they have maintained compliance with the program standards.

The Law Enforcement Agency Accreditation Council

The Council is the governing body for the program as established through New York State Executive Law §846-h. The Council develops and approves program standards and adopts policies that determine how the program is administered. It also has the sole authority to award accreditation to an agency. The Law Enforcement Agency Accreditation Council meets quarterly; meeting minutes from 2021 meetings are in Appendix C.

The Professional Policing Act of 2021 amended Executive Law §846-h and the Council's composition. The law requires the Council to have 19 members appointed by the Governor with the exception of two ex-officio members: the New York State Police superintendent and the New York Police Department commissioner.

The following organizations must nominate members for gubernatorial consideration: the New York State Association of Chiefs of Police (two); New York State Sheriffs' Association (two); the New York State Deputies Association (one); police labor organizations (two); New York State Association of Towns (one); New York State Conference of Mayors (one); New York State Association of Counties (one); the New York State Senate and Assembly (one each); and the academic community (one). The council also must have an incumbent police chief or police commissioner from a police department consisting of more than 100 officers (one); incumbent sheriff from an agency with more than 100 deputy sheriffs (one); a representative of victims of crime (one); and a representative from a community with high numbers of police and community interactions (one).

DCJS Office of Public Safety

DCJS is the agency responsible for administering the Law Enforcement Agency Accreditation Program under Title 9 of the Official Compilation of Codes, Rules and Regulations of the State of New York, Part 6035. Members of the Accreditation Unit within the agency's Office of Public Safety administer the day-to-day activities of the program in accordance with statute and the policies set forth by the Council. They also provide a significant amount of assistance to program staff of accredited and applicant agencies.

Council Support

Accreditation Unit staff members provide all professional and administrative support to the Council. They coordinate the Council's quarterly meetings: preparing agendas, compiling information related to matters up for a vote and informing the Council about updates or potential issues with the program. Accreditation Unit staff members also review Council policies for accuracy and relevance; revise those policies when necessary; and draft new policies based on program needs.

The unit ensures that Council meetings follow the state's open meetings laws, including arranging for the video recording of meetings so they are available to the public, and preparing and distributing meeting minutes in a timely manner.

Agency Support

Accreditation Unit staff members offer technical assistance and support to agencies pursuing or maintaining accreditation by explaining the standards; aiding in program development; providing feedback on agency policies; and offering guidance on how to best demonstrate compliance with the standards. They also assist agencies in overcoming obstacles to become accredited and work with accredited agencies to help ensure ongoing compliance with program standards.

Unit staff members work with agency program staff to determine an agency's readiness for assessment; select assessors for each assignment; handle all logistics to ensure the agency and the assessors are prepared for the assessment; and monitor the progress of the on-site

assessment. Accreditation Unit staff strive to assist every agency in being successfully accredited and in maintaining that designation.

Accreditation Unit staff members visit every accredited agency at least once during the period of accreditation. These site visits are designed to ensure agencies are maintaining compliance with the program and identify agencies that are facing challenges with compliance. When necessary, unit staff require corrective action plans for agencies that are struggling to maintain compliance and staff will provide enhanced technical assistance so agencies can return to compliance. Staff members conducted 58 site visits in 2021.

Finally, in addition to regular technical assistance, accreditation unit staff develop, coordinate and deliver trainings for agency program managers, command staff and program assessors.

Assessors

Individuals interested in becoming assessors must apply for those positions through a request for applications issued by DCJS about every five years, and each assessor must be vetted by unit staff and approved by the Council. Applicants must demonstrate that they have the necessary experience, either through the direct management of their agency's accreditation program, or through direct supervision of individuals who manage the program. Once approved by the Council, DCJS contracts with individuals, who must attend a day-long training session prior to being considered for assignment to an assessment team. Individuals selected as assessors also receive additional training by being partnered with the program's most experienced assessors during their first few assignments.

DCJS added three assessors in 2021, bringing the number of active assessors to 109.

Program Participation

As noted, the Law Enforcement Agency Accreditation Program is voluntary. At the end of 2021, 161 agencies were accredited, about 29 percent of the 540 law enforcement agencies in the state eligible to participate. Accredited agencies in the state employ nearly two-thirds of all police officers and sheriffs' deputies who work outside of New York City. The number of accredited agencies has increased annually since 2008 (see page 6 for more details).

Accredited Agency Activity in 2021

At its March meeting, the Council awarded accreditation for the first time to two agencies. The Council reaccredited a total of 31 agencies at its quarterly meetings in March, June, September and December. Please see Appendix A for a list of accredited agencies and Appendix C for meeting minutes.

Applicant Agencies


At the end of 2021, 46 agencies were working toward accreditation, with four of them scheduled to undergo their initial assessment in 2022. Applications for accreditation have increased by more than 140 percent following Executive Order 203 (New York State Police Reform and Reinvention Collaborative) and the Professional Policing Act of 2021. Please see Appendix B for a list of applicant agencies.

In 2021, 207 agencies were either accredited or actively working toward accreditation; this is 17 more than at the end of 2020.

Withdrawn or Expired Agencies

The SUNY Oswego Police Department voluntarily forfeited their accredited status in 2021 because of difficulty in maintaining the administrative requirements of the program.

2021 Program Updates

Implementation of Versions 8.6 and 8.7 of the Standards and Compliance Verification Manual

The Council approved two updates to the program's Standards and Compliance Verification Manual.

Version 8.6 implemented revisions to three existing standards: Standard 25.1 (Internal Affairs – Critical Standard), Standard 32.1 (Basic Course for Police Officers – Critical Standard) and Standard 42.3 (Seat Belts). This version was subsequently superseded by Version 8.7, which:

- Added two new standards Standard 4.1 (Officer Wellness), and Standard 9.1 (Reporting Requirements – Critical Standard);
- Revised existing Standard 12.1 (Hiring Standards Critical Standard); and
- Removed Standard 12.7. Standards 9.1 and 12.1.

These changes will help agencies comply with the Professional Policing Act of 2021.

Accreditation Unit staff notified all accredited agencies that they were required to comply with Version 8.7 of the manual by April 1, 2022. To help ensure agencies had sufficient information to meet the new requirements by the deadline, staff compiled and distributed detailed, step-by-step guidance on the policies necessary to meet new standards and amended to meet revised standards. Staff also provided guidance on the restructuring of program files to account for standards that had been consolidated into others.

Accreditation Unit staff conducted site visits to verify that agencies had successfully converted to the new standards and provided technical assistance to agencies needing help to meet the new requirements. Staff also added a section to the Annual Compliance Survey that addressed compliance with the new standards. Verification of compliance with Version 8.7 continues.

Development of the Mandatory Certification Process

The Council and Accreditation Unit staff began developing a mandatory certification process to ensure that all police agencies are conforming to hiring standards prescribed by the New York State Municipal Police Training Council as required by the Professional Policing Act of 2021. That law also requires village, town, city and county police agencies to comply with reporting requirements to the Central State Registry of Police and Peace Officers, which is administered by DCJS, and to report police officer misconduct.

The mandatory certification process will allow the state to oversee compliance with all required hiring and reporting standards. The law gives the Council the sole authority to certify, revoke or withhold certification, which police agencies covered by the law must obtain by October 16, 2023. An agency's failure to achieve and maintain compliance with these standards may result the Council withholding or revoking certification, which affects the agency's ability to employ police officers under state Criminal Procedure Law Section 1.20 (34).

Training

The Accreditation Unit offered two virtual and one in-person program manager trainings attended by 185 program managers, chief law enforcement officials, command staff and other agency staff, and two virtual and one in-person assessor trainings attended by 62 assessors and individuals seeking to become assessors.

Plans for 2022

- Staff will coordinate assessments for 27 agencies with accreditation due to expire in 2022 and four agencies scheduled to be assessed for their first accreditation.
- Accreditation Unit staff will offer a minimum of two program manager trainings and two assessor trainings during the year.
- Accreditation Unit staff will continue its work to expand participation in the program by promoting the benefits of accreditation while ensuring agencies receive the technical assistance and support necessary to achieve and maintain accredited status.
- Staff will work with the Accreditation Council to: implement the mandatory certification process; begin conducting assessments; and provide technical assistance and support

to agencies required to achieve and maintain certification under the Professional Policing Act of 2021.

Conclusion

The New York State Law Enforcement Agency Accreditation Program continues to be a source of great pride for the more than 20,000 law enforcement professionals employed by accredited law enforcement agencies. The Council and the Accreditation Unit are committed to the integrity and longevity of the program through continuous evaluation and enhancement to ensure that it meets the ever-changing needs of law enforcement professionals throughout New York State.

11. Program Updates

Article VII Legislation:

Commissioner Green updated the council on the article 7 proposals in the new budget plan proposed by Governor Cuomo. The first relevant proposal is in regard to uniform hiring and training standards. This proposal requires the MPTC to establish mandatory minimum hiring standards. These mandatory items would include criminal history, background checks, medical checks, and physical and mental health exams. This would also require the LEAP council to issue certificates of compliance certifying that the agencies are in compliance with hiring requirements and reporting requirements to the DCJS police/peace registry. If an agency does not obtain a certification their officers would no longer qualify as police officers and will not have police powers.

An additional proposal would be to require agencies to give a conduct-based reason for decertification of an officer which will be noted on their records to prevent officer from obtaining a new certificate under a different agency.

A restructure to the seating members of the MPTC and the LEAP council was also proposed. It would include that the superintended of the State Police being included as a required member on the MPTC and a chief of an agency of over 100 officers, a sheriff from an agency with over 100 sheriff's deputies, a representative for crime victims, and a representative for a community voice would be included on both MPTC and LEAP councils.

Council Members Appointments:

Mr. Marruso updated the council of 5 new members, 2 reappointments and the appointment of Chief Austin to Chairman of the council. The new members are Chief Joseph Sinagara, Chief Marvin Flatley, Sheriff Todd Baxter, Sergeant Leighton Filiatrault, and Detective (ret) Michelle Randall Williams. Sheriff Virts and Sheriff Maciol were both reappointed to their position.

Remote Delivery of Program Manager and Assessor Trainings:

Mr. Marruso informed the council that the accreditation unit has conducted another program manager and assessor training. Due to the number of registrants for the program manager training the accreditation unit has created 2 additional program manager trainings in March.

Agency Withdrawal – SUNY Oswego University Police Department:

a. Article VII Legislation

Commissioner Green updated the council on the new budget plan which will be in effect 180 days after the law is signed. The first section is in regard to uniform hiring and training standards. This I requires the MPTC to establish mandatory minimum hiring standards. These mandatory items would include criminal history, background checks, medical checks, and physical and mental health exams. This would also require the LEAP council to issue certificates of compliance certifying that the agencies are in compliance with hiring requirements and reporting requirements to the DCJS police/peace registry. If an agency does not obtain a certification their officers would no longer qualify as police officers and will not have police powers.

Additionally, this law requires agencies to give a conduct-based reason for decertification of an officer which will be noted on their records to prevent officer from obtaining a new certificate under a different agency.

A restructure to the seating members of the MPTC and the LEAP council will also occur. It will include that the superintended of the State Police being included as a required member on the MPTC and a chief of an agency of over 100 officers, a sheriff from an agency with over 100 sheriff's deputies, a representative for crime victims, and a representative for a community voice would be included on both MPTC and LEAP councils.

b. On-site assessments, field visits and in person training

Gabe Marruso informed the Council that due to the Effective May 19th, New York State adopted the CDC's "Interim Public Health Recommendations for Fully Vaccinated People" for most business and public settings. The CDC's recommendations allow for fully vaccinated individuals to refrain from wearing masks or practicing social distancing. In lieu of the progress New York State has experienced with regards to COVID-19, DCJS, the Office of Public and the Accreditation Unit seek to resume more traditional on-site activities, including assessments, fieldvisits and in-person training. 11. Program Updates

a. Professional Policing Act of 2021

Commissioner Green informed the council that the Professional Policing Act (PPA) requires all police departments in NYS to adopt and comply with hiring standards set by the MPTC. The MPTC did adopt proposed standards and currently the standards are awaiting approval from chamber to then be posted for public comment. Across the board the police departments and Sheriffs Offices agreed that logistically the polygraph portion makes sense however it may be difficult for some departments. Due to this, the section was amended to make it voluntary as opposed to mandatory. The act fully takes effect in October of 2023 in which all agencies must be in compliance with the accreditation hiring standards.

Gabe Marruso also informed the council that the accreditation unit must have all the agencies certified by October 2023. The accreditation council will have the authority to revoke or suspend certification or accreditation status if an agency is not in compliance. The accreditation unit is working internally to create timelines for certifications and will send out notifications in advance of any expiring certificates. The unit will be working hard to do everything they can to assist and ensure that agencies are in compliance with PPA and accreditation hiring standards. The unit will be modeling the current accreditation format for assessments. The December council meeting is when the unit will be looking to implement the hiring standards. Verification will be made through proofs of compliance during site visits made by unit staff. Annual certification for agencies is critical to remain in compliance.

b. Officer Wellness

The Accreditation unit is looking to implement a standard on officer wellness. Scott Neff from the Training unit provided an overview of the officer wellness curriculum that was added to the Basic Course for Police Officers.

The main points of the standard will include:

- a. Access to Resources
- b. Best Practices (Sleep, therapy, stress management, etc.)
- c. Prevention and Intervention
- d. Peer Involvement and Support
- e. Critical Incidents

c. Program Manager and Assessor Training

The accreditation unit held a program manager and assessor training at the Monroe County Public Safety Training Center on August 24th, and 25th. The program manager had 24 individuals in attendance and 9 attended the assessor training. In total in 2021, the accreditation unit hosted 4 program manager trainings

and 2 assessor trainings.
