Sexual Offense Evidence Kit Inventory Report 2024

May 2025

Overview

This report is published pursuant to state Executive Law Section 838-a, which requires law enforcement agencies and public forensic laboratories to report data detailing the number of sexual offense evidence kits they receive, process or test each quarter during the calendar year.

The law designates the state Division of Criminal Justice Services (DCJS) as the agency responsible for informing police agencies, district attorneys' offices and public forensic laboratories about their data reporting obligations. DCJS also must collect these data and submit an annual report to the leadership of the New York State Senate and Assembly that details the data reported by these agencies.

Police departments, sheriffs' offices and district attorneys' offices are required to report:

- the number of sexual offense evidence kits received during each quarter;
- the number of kits received each quarter that were submitted to a forensic laboratory;
- the number of kits received each quarter that were submitted to a forensic laboratory within 10 days;
- the number of kits received each quarter that were submitted to a forensic laboratory more than 10 days later; and
- the total number of kits that remained in inventory at the end of each quarter.

Forensic Laboratories are required to report:

- the number of sexual offense assault kits received during each quarter;
- the number of kits received each quarter that were processed;
- the number of kits received each quarter that were not tested; and
- a reason why untested kits were ineligible for testing that quarter.

Table 1: Police Agencies and District Attorneys' Offices**Summary:**

- 547 (91%) of 604 agencies provided data for this report.
- 3,137 kits were received by those agencies during 2024.
- 35 kits were received and remained in the agencies' custody and control in the first quarter; 14 in the second quarter; 17 in the third quarter; and 25 in the fourth quarter. Law enforcement agencies are not required to report to the state whether kits remaining in their custody and control at the end of the quarter were sent for processing in subsequent quarters.

Table 2: Public Forensic Laboratories**Summary:**

- All nine forensic laboratories in the state provided data for this report.
- 3,284 sexual offense evidence kits were sent to those labs during 2024.
- 2,883 kits were processed as of December 31, 2024. This includes 1,082 kits completed in the quarter in which they were received. The remaining 1,801 kits were received prior to 2024 but completed during 2024 or received during one quarter of 2024 but completed in a subsequent quarter of 2024.
- 429 kits were not assigned to an analyst in the quarter in which they were received. Labs are not required to report to the state whether those kits were assigned to an analyst and/or completed in subsequent quarters.

Note:

Tables 1 and 2 list all police departments, sheriffs' offices, district attorneys' offices and public forensic laboratories required to report to DCJS and the corresponding data they reported to the agency.

Entities that did not report for a particular quarter(s) are denoted with an asterisk.

Information contained in this report was provided to DCJS by law enforcement agencies and laboratories as of Mar. 4, 2025.
