NYPD UCR Domestic Violence Report by NYC County

New York City 2018 data appears in a temporary format while the NYPD's Uniform Crime Reports are being developed. While the rest of the state used UCR crime categories of "aggravated assault" and "simple assault", NYC data instead shows the categories of "felonious assault" and "assault third degree & related offenses". The statistical tabulations presented for New York City are derived from top charge of the reported complaint and the relationship/intimate partner information collected by the NYPD crime reporting system.
