# DCJS Hosts Information Exchange Webinar

DCJS recently hosted an online information exchange session for the 20 County Re-Entry Task Forces funded by the agency to discuss the programmatic changes occurring as a result of the COVID-19 pandemic. More than 90 re-entry professionals across the state participated, including Task Force co-chairs and coordinators, as well as staff from DCJS and the state Department of Corrections and Community Supervision.

Led by DCJS Community Correction Representative 3 Michele Clarke, the webinar offered guidance and information on alternate methods that Task Forces could use to continue providing services while adhering to federal, state and local directives in response to the outbreak. DCJS Staff Taylor Vogt and Melinda Vick presented comprehensive information on technology platforms that allow re-entry professionals to continue providing services that address the stabilization and criminogenic needs of individuals returning to their communities after incarceration. The webinar explored:

- Using available video technology: WebEx, GoToMeeting, Skype, G-Suite, Google Duo & FaceTime, in addition to telephone conference calls to engage with participants;
- Centralizing incoming calls through voice mail by providing a phone number where individuals can leave messages;
- Designating or creating a specific email address where anyone can ask questions or voice concerns; and
- Communicating through social media platforms and/or websites, among other strategies.

"The world is facing unprecedented times due to COVID-19 and as criminal justice and re-entry professionals we are being challenged in our ability to continue to deliver consistent re-entry-based services while adhering to public health and safety mandates....
