#### County Re-entry Task Force Services — In Action

#### **OPCA delivers Interactive Journaling Training**

Twenty community corrections professionals attended training for Interactive Journaling on December 19 and 20. Upon completion, graduates are trained to facilitate Interactive Journaling groups and individual sessions. Interactive journaling is an evidence-based, cognitive behavioral intervention that aims to help participants move through the stages of change.

### Cara House - Schenectady County

The Cara House, which will be a major resource for those struggling with homelessness, hosted a ribbon cutting ceremony on Thursday, Nov. 30, 2023. The Cara House, located at 917 State St., Schenectady, will provide 26 permanent supportive housing units,10 of which will be dedicated for chronically homeless individuals. Sixteen emergency shelter beds will be provided to members of the re-entry population who are unhoused.

#### **Governor Announcements:**

Governor Kathy Hochul signed the Clean Slate Act (S.7551A/A.1029C), which seals certain criminal records and allows individuals to seek employment, education, and obtain housing opportunities so they can improve their lives. The law, enacted on November 16, 2023, will allow for records to be sealed following the release from incarceration, provided those individuals have maintained a clean record and are no longer on probation or parole supervision. ## Client Testimonial - New York County Re-Entry Task Force

Kasiem C. was released after serving over 40-years in state incarceration. Since his release, he has displayed a determined effort to successfully reintegrate back into society. He has completed a cognitive behavioral intervention - employment program and is an active participant in Interactive Journaling groups. He is enrolled in a Social Services 101 course to eventually become a peer counselor and has secured housing at the Fortune Society transitional housing program. The Task Force assisted Kasiem with obtaining his personal documents, such as identification, birth certificate and social security card, and helped him find a primary care physician. The Task Force coordinator noted, "His attitude is one of gratitude. He has shown true efforts towards redemption and positive determination."
