- 1. Justice Mental Health Collaboration Grant Program Commences in Westchester County

On Dec. 3 and 4, the NYS DCJS Justice and Mental Health Collaboration Program (JMHCP) began its implementation in Westchester County. The DCJS Office of Probation and Correctional Alternatives received a federal grant for \$250,000 through the US Department of Justice--Bureau of Justice Assistance which will be used to implement the JMHCP in up to 10 Operation IMPACT jurisdictions in New York. The goal of the grant is to reduce crime and achieve more successful outcomes for individuals with mental illness engaged in the criminal justice system. Monroe, Nassau, Rensselaer and Schenectady are also part of Phase One of the JMHCP. The program implements the Sequential Intercept Model (SIM), developed by Policy Research Associates (PRA), which also serves as the primary consultant to the JMHCP. The SIM will engages criminal justice and mental health professionals in each of the county pilot sites to identify opportunities in the criminal justice process, from arrest through disposition and re-entry, to screen, evaluate and engage individuals with mental illness in treatment and more effective supervision and case management . The NYS Office of Mental Health (OMH) is partnering with DCJS in implementing the JMHCP, and announced that it will provide \$100,000 in state funding to county mental health departments in the five pilot sites to work on screening, assessment, treatment and pre-release planning for individuals detained and sentenced in local jails. Nearly 50 county leaders and staff were present for this event organized by the Westchester Departments of Probation and Community Mental Health.

The primary components of the JMHCP will include sequential intercept mapping; critical incident training in the Emotionally Disturbed Persons Response Teams curriculum for police, probation and first responders; technical assistance in implementing the Community Care Coordination Program; training in probation/mental health supervision and case management; peer advocacy support and the use of specialized screening and assessment tools at the pretrial services, probation and jail intake stages of the criminal justice system.

2. DP30/30A Workload and Sex Offender Registry Address Confirmation Reports

AutoMon, Inc. has deployed updates to the DP30/30A workload reports which have resolved the financial reporting issue for counties that allocate their funds at times other than at the time of payment. Additionally, AutoMon has deployed a fix to the Sex Offender Registry Probationer Home Address Confirmation report which will now properly capture those sex offenders who had open supervision cases during the period for which the report was run. Please ensure that all workload reports are uploaded, sequentially, to the DCJS Integrated Justice Portal. Instructions describing the upload process for CE and non-CE counties.were issued to each department.

3. Juvenile Justice Translational Research on Interventions for Adolescents in the Legal System (JJ Trials)

The National Institutes of Health - National Institute of Drug Abuse has selected Columbia, Emory, Mississippi State, Temple, and Texas Christian Universities to implement the JJ Trials Research Program to better assess how juveniles access treatment for mental health services and provide insight into the current state of HIV and substance abuse/mental health delivery systems. Chestnut Health Systems will serve as the coordinating center. This \$5 million, multi-year program will be implemented through cooperative agreements with the five national university sites. Each university has selected a juvenile justice partner; in New York State, Dr. Gail Wasserman of the Columbia University Center for Juvenile Justice and Mental Health selected the DCJS Office of Probation and Correctional Alternatives as the juvenile justice partner for research. Four NYS county probation partners have been chosen to participate in this project based on an analysis of DP30 Reports and juvenile justice --YASI data. They are Nassau, Niagara, Onondaga and Schenectady counties. The overall goals of the project will lead to improving delivery of evidence based practices addressing prevention and treatment services (Study Protocols) and advancing implementation science (methods and publications)

6. Awards, Events, Additional Trainings and News

We are pleased to announce that Yvonne Behan, manager of the ATI and Re-entry units at OPCA, was recently awarded the NYS DCJS <u>Commissioner's Award for Public Service</u>. This award recognizes individuals who have made prominent contributions in support of what DCJS does to enhance the services provided to the criminal justice community. Congratulations Yvonne - well deserved!

Enhancements have been made to CIRIS (Critical Infrastructure Response Information System), the integrated web mapping application that has been available via the New York State Integrated Justice Portal (IJ Portal) since 2009. CIRIS provides on-demand statewide mapping capability and contains easy to access tools for searching, geographic analysis and evaluation. CIRIS is currently used by the state Department of Corrections and Community Supervision (DOCCS, county probation departments and social services departments to identify and manage the location of sex offenders, particularly in relation to educational and child-care facilities. Authorized IJ Portal users are able to access CIRIS via the portal web site **Resources >> Mapping** pull-down menu. Requests for CIRIS access are coordinated through agency Terminal Access Coordinators (TAC). More than 2,000 IJ Portal users, predominantly in county and municipal law enforcement, have been authorized for that access. Training for CIRIS will be offered in the Albany area in early 2014.
